### **FAE Standing Rules 1 – Establishment of Benevolent Fund Subcommittee**

Each year, on or before the first meeting of the fiscal year, the FAE Trustees shall establish a Benevolent Fund Subcommittee composed of the FAE president, President-Elect, and Treasurer.
